

### **Post Family Farm Free Wedding Package Official Rules**

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE YOUR CHANCE OF WINNING.**

**PROMOTION DESCRIPTION AND TIMING:** The Post Family Farm Free Wedding Package Drawing ("Sweepstake") begins at 12:00 AM Eastern Time ("ET") on 4/15/08 and ends at 5:00 PM ET on 5/01/08 (the "Promotion Period").
