Payment Schedule

First Installment

We require a deposit of 50% of the Base Price along with your completed reservation form to reserve your date. We will hold your date for 5 days without a deposit.

Second Installment

75% of your estimated total bill is due two months prior to your event date.

Final Payment

Final payment is expected on or before your event date and is based on the final guest count given 5 days prior to your event date.

Cancellation Policy

Cancellations made more than 6 months prior to the scheduled event date will be refunded 50% of the "First Installment" payment. Cancellations made more than 3 months but less than 6 months prior to the scheduled event date will forfeit the entire "First Installment" payment. Cancellations made more than 2 months but less than 3 months prior to the scheduled event date will forfeit the Base Price of the selected package. Cancellations made within 2 months of the scheduled event date will forfeit the entire "Second Installment" payment.
